You CANNOT, for example, submit only Assignment 0. Assignment 02 will be in Tutorial Letter 102 and Portfolio Assignment 3 will be in Tutorial Letter 103.

Please start working on your assignment well in advance of the due date. You will note from the tutor-facilitated contact schedule in TUT 301 that you have to submit the assignment the next session after discussing the relevant units, so do not delay!

1.1 What are the submission dates for assignments?

1.2 Why is it important to submit assignments on time?

One of the reasons why assignments must be submitted on time is because the UNISA system for submitting assignments marks has certain cut-off dates per semester when which are cut-off dates. After those dates the system will not take any marks. You have not to be concerned about Module 2 as the date has been extended accordingly. The first two assignments also allow you to submit the portfolio as final assessment as if an examination.
